RIGHT TO HEALTH

Esteemed members of API, Odisha State Branch,

Greetings from API State Headquarters

Now I wish to share the views of Hon'ble Supreme Court regarding right to health as a fundamental right.

As we all know, Health is a state of complete physical, mental, social well being and not merely absence of disease with an ability to lead a socially and economically productive life (WHO). By explicitly including the mental social dimensions of well being WHO has radically expanded the scope of Health, and by extension, the role and responsibility of Health professionals.

In the universal declaration of Human right adopted by UNO General Assembly on 12th December 1948, it has been declared that every human being has a right to dignified life. As a signatory to UN General Assembly India is a party to it.

Right to health is not included directly in as a fundamental right in the Indian Constitution. The constitution directs the state to take measures to improve health care of the people, through Directive of principle of state policy.

The article 21, 38, 39(e), 41, 42, 47, 48(A) through their importance to public Health are interpreted through highest judiciary as right to health is a fundamental right.

Article 21 guarantees with 'No person shall be deprived of his life or personal liberty except according to procedure established by law'. Right to live means more than mere animal existence and includes to live consistently with human dignity and decency.

In 1995, the Supreme Court held right to health and medical care, is a fundamental right covered by article 21. The state has an obligatory under article 21 to safe guard the right to life of every person. (In case of Parmanand Katra Vs Union of India – a scooterist who was knocked by a car and was refused treatment on pretext by medico legal case by primary care physician for want of Police report and referred to another hospital).

Justice Ranganath Mishra who wrote the judgement declaring right to health is a fundamental right, reads like-

"There can be no opinion that preservation of human life is of paramount importance, that is so on account of the fact that once life is lost, the status quo ante cannot be restored as resurrection is beyond the capacity of man. The patient whether he be an innocent person or be a criminal liable to punishment under the laws of the society, it is the obligation of those who are in charge of the health of the community to preserve life so that the innocent may be protected and guilty may be punished. Social laws do not contemplate death by negligence, tantamount to legal punishment".

This decision clarified, right to health is fundamental right and immediate assistance from govt hospital, corporate hospital or otherwise is absolute, irrespective of whether he was a medico legal case or whether he was a criminal.

The court laid following guidelines for doctors when an injured person or any critically ill person approaches them.

- 1) Doctors should give sufficient assistance at his disposal to the patient and if there is not sufficient to save the life of the person it is duty of the doctor to see that the person reaches the proper expert as early as possible.
- 2) All doctors are legally protected while treating an injured or critically ill person. The doctor does not contravene the law of the land and should be protected.
- 3) No legal law for doctors for attending to injured person for medical assistance.

Supreme Court in different cases opined that right to pollution free water and air is enforceable fundamental right guaranteed under article 21.

Supreme Court imposed a positive obligation upon the state to take steps for ensuing to the individual a better enjoyment of life and dignity and for elimination of water and air pollution, the maintenance and improvement of public health is the duty of state to fulfill the constitutional obligation cast on it under article 21 of constitution (Vincent Vs Union of India)

In summary, even though our constitution makers did not list the Health as a fundamental right, our Supreme Court on several occasion have interpreted health as a fundamental right under article 21, 38, 39(e), 42, 47, 48(A). As the law of our county now stands, every person has a right to health as part of this right to life under article 21 of constitution which includes right to medical treatment, in every hospital owned by state or its agencies limited to economic capacity of the State.

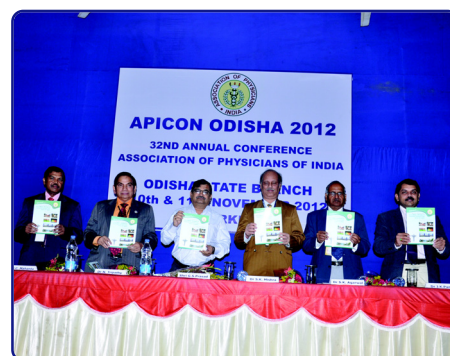
