Respected Members,

It has been brought to notice that following points had been decided in Governing Body meeting of previous calendar years to include in constitution of Association of Physician of India, Odisha State Chapter.

1. Association" means Association of Physicians of India in other words **A.P.I. (ODISHA STATE CHAPTER)**
2. "CITY-BRANCH" shall mean and include different units of the Association either opened or recognized by the Association.
3. **Chairman Elect :**
He/ She will work as Chairman scientific Committee. He/ She shall be elected alternately from amongst the members serving or have served as members of the faculty (regular teachers) in any recognized Medical Colleges in Odisha (Category-A) and member physicians in practice/ serving in non-teaching institution in Odisha (Category-B).He / she shall automatically become Chairman for next calendar year.
4. There will be **no election for the posts of Chairman.**
5. **Co-opted members :**

He/she must be member of API (State/ Central) and have significant contribution towards API State Chapter activities. Governing Body will decide number of Co-opted members and invite them.

As per amended constitution (08/11/2014), any changes/ modification required, it must be passed in General body meeting with 2/3rd majority of the member present and voting. So there will be ^{Extraordinary} General Body Meeting on 15th March 2026 at 12Noon at IMS and SUM Hospital, Bhubaneswar for modification of Constitution of API, Odisha State chapter.
